ARTS AND CRAFTS & FLEA MARKET SET UP INFORMATION

1. Registration received by August 1: \$30.00 for 20' x 20' with additional spots being \$20.00.
2. Registration received after August 1: \$35.00 for a 20' x 20' spot with additional spots being \$25.00.
3. Returning vendors must submit an application and fees before May 1, 2022 to be guaranteed last year's spot.
4. Please list names and addresses for everyone selling items in your booth spot.
5. No water hook ups!
6. All trailers, tables, etc. must fit in your spot. Vehicles allowed only for loading & unloading. Vehicles must be moved to general parking.
7. Vendors will be responsible for his/her own tables, chairs, insurance, and Illinois sales tax. A special event tax collection report and payment coupon will be given to each vendor at the festival if you do not have an Illinois Sales Tax number. See letter on back of this page.
8. Vendors are asked to keep their areas clear of trash
7. Flea Market and Arts & Crafts set up will begin at 8:00 am on Friday, September 2, 2022 **weather permitting**. Special arrangements **MUST** be made with chair person in the event the vendor cannot set up on Friday at 8:00 am. **Vendor will be fined if grounds are torn up.**
8. **The Nauvoo Grape Festival Association requires that all vendors respect other vendors.** If problems continue vendor will be asked to leave and not be invited back.
9. Make checks payable to Nauvoo Grape Festival Association, all returned checks will be charged double the amount of the check.

Dear Grape Festival Vendor:

Beginning January 1, 1994, Public Act 88-480 provides that any person who promotes, organizes, or provides retail selling space for concessionaires or other types of sellers at fairs, art shows, fleas markets and similar events is required to file a report with the Illinois Department of Revenue.

The following information must be reported for each vendor:

- Name of vendor's business
- Name of the person or persons engaged in the vendors business
- Permanent address of the business
- Illinois business tax (IBT) number of the business
- Dates and location of the event

This means that all vendors at Grape Festival or any special event held in Illinois must have an Illinois tax number on the line below your signature. If you do not have one at this time write in "applied for" on the line provided. You will then need to write to the address below to get your tax number. There is no charge for the number.

An Illinois Tax Number is required by law. You must bring your Illinois Tax Number with you the weekend of the Grape Festival.

A Special Event Tax Collection Report and Payment Coupon will be given to each vendor at the festival if you do not have an Illinois Sales Tax number.
